Since the attacks on September 11th, 2001, intelligence activities has been one of the most controversial issues facing this country with one of the most controversial being the Department of Homeland Security (DHS). Created in November of 2002 and conceived just two weeks after the attacks, the DHS focuses in five goals; prevent [terrorism](#) and enhance security, secure and manage the borders, enforce and administer immigration laws, safeguard and secure cyberspace, and ensure resilience to disasters. In order to achieve these goals, intelligence is necessary. The Office of Intelligence and Analysis, a subsection to the DHS focuses on obtaining and analyzing intelligence and puts them into the Homeland Security Enterprise which primarily consists of intelligence from organizations such as the US Secret Service, Coast Guard, and Transportation Security Administration. Recently, as a result of compromised programs of the National Security Agency, both the NSA and DHS have been backlashed in that they are both inefficient and do not obtain intelligence in a proper fashion as well as that they infringe upon the civil liberties of their citizens. The State of Florida feels that intelligence activities must be amended in a fashion in which the effective fight in the war on terror is continued and further progressed without infringing upon the civil right to privacy of citizens.
